(Readings from each unit are automatically transmitted back to RWCC and billed monthly)

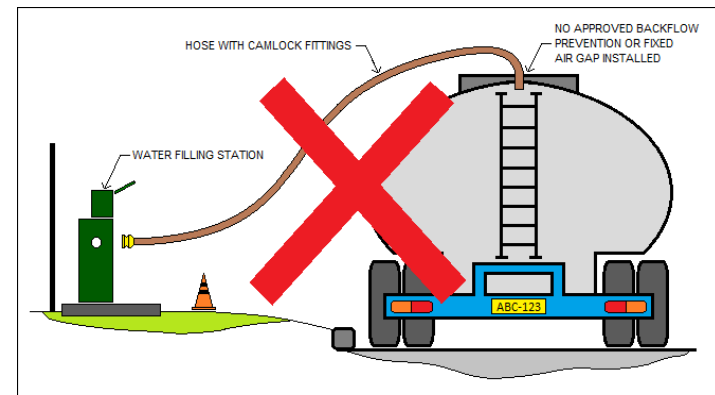
CONDITIONS OF USE

I acknowledge I have read and understood all the conditions of use:-

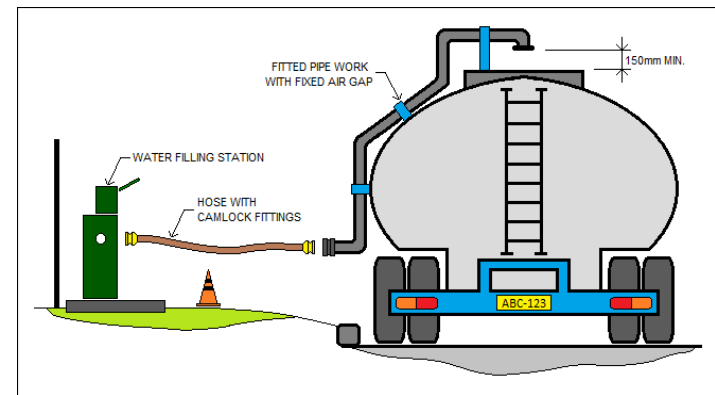
- I understand that it is illegal to use Portable Standpipes in RWCC hydrants. (Fire Brigades & Council excepted)

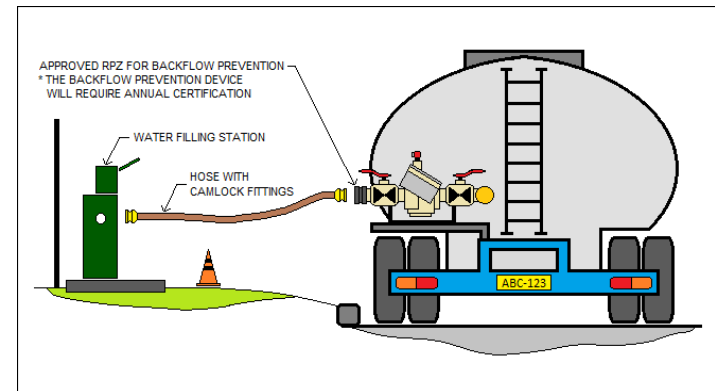
